All communication including but not limited to, lesson confirmations and cancellations, are to be done by EMAIL ONLY. It is your responsibility to know the lesson polices and adhere to them (please initial all points below):

_____Lessons are only booked by the month, there is no pay as you go option

_____There are no refunds for missed or forfeited lessons. You will be billed based on the number of lessons in the monthly session:

Group lessons:

- \$280 + HST (4 lessons a month)
- \$350 + HST (5 lessons a month)

Private lessons:

- \$360 + HST (4 lessons a month)
- \$450 + HST (5 lessons a month)
 Semi-Private lessons:
- \$280 + HST (4 lessons a month)
- \$350 + HST (5 lessons a month)

_____ Since riding is a year-round sport, 1 months' notice is required to leave the program and must be given on the first of the month. Otherwise, you will be charged for the next months' lessons whether or not you ride

_____ In circumstances of inclement weather, Lake House Stables only will make the call if lessons are canceled. There will be cases where stable management lessons may have to replace riding lessons

_____Students are required to come 30 minutes prior and stay 30 mins after, this is to care and groom for their horse. In situations where the student is continually late or leaves early, a grooming and tack cleaning fee will be charge at \$25 per day

_____You must have an accurate and up to date file in order to ride. This includes a signed lesson registration, waiver and completed credit card form. We may request these forms from you as we work on making sure all items are accounted for

Please initial all points below:

1. For the safety of the horses, students and family, only staff and riders are permitted in the barn areas. Covid permitting viewing rooms will be open for parents and spectators. These are designated areas separate from the barns

____2. No dogs will be permitted on the property

____3. Office hours are Monday to Friday 9 am to 5 pm, We are not staffed full time in the office, so please allow 48 hours for responses to emails

_____4. We ask that texts also come between work hours, unless it is an emergency

_____5. Lesson payments are due on the first of the month, a late fee \$15 will be charged for anyone who pays later then the 10th. If paying by cheques, we will now require posted dated cheques only. There will be a \$50.00 charge for all NSF cheques.

____6. In any cases of NON payment and collection action is necessary, the customer agrees to pay the cost of collecting, including attorney's fee and/or collection agency fee plus all fees and interest.
